

# A guide to further sources of Legal Aid or Pro Bono support for clients in Stirling District and the Forth Valley

#### Introduction

Stirling District Citizens Advice Bureau<sup>1</sup> (CAB) is a local, independent charity which provides free, impartial and confidential advice and information, empowering people in Stirling and the surrounding Forth Valley to sort out any issues or problems and realise their rights.

We're at the heart of the community and offer person-centred and holistic advice and advocacy across a wide spectrum of issues, including those relating to social security benefits, housing and energy, workplace problems, money and debt, family, healthcare and patients' rights, consumer issues, and the law and courts.

In more complex cases which require legal advice, clients need to be signposted or referred to legal professionals who operate in the category of law for which support is sought. However, we have been experiencing significant difficulties in signposting locally for both pro bono and legal aid work. Our recent research report Access to Social Justice in Stirling District and the Forth Valley (ADD HYPERLINK) evidences this dire situation and highlights serious gaps in provision of local legal aid and pro bono support.

This needs to be urgently addressed to ensure the right to access to justice is a reality for people living in Stirling and Forth Valley. While this will require concerted efforts by local and national governments, third sector organisations and the legal professions alongside adequate funding, in the meantime, **this guide outlines sources of legal assistance** both locally and nationally where clients can be referred, according to the nature of their enquiry.

This practical guide focuses on certain categories of client and/or areas of civil law for which the bureau has difficulty in identifying where to signpost or refer clients to for legal assistance or representation. We hope, however, that it will be of assistance to anyone in the Forth Valley in need of legal advice or those seeking to support others with legal problems.

#### The guide considers

- > types of issue that a client's **household insurance legal protection policy** may cover, thus negating the need for referral
- > categories of civil law for which legal aid assistance is available from **local solicitors**
- > Specialist charities providing legal support for issues affecting children
- > Specialist charities providing legal support around issues to do with ethnicity, migration, asylum seeking and people trafficking
- > Discrimination and 'protected characteristics' Scottish Just Law Centre
- > Disability specific legal project run by **Legal Services Agency**
- > Types of legal support on housing issues provided by **Shelter**
- > Domestic Abuse Scottish Women's Rights Centre
- > Legal issues undertaken by **Edinburgh Napier University Law Clinic** who offer their services across Scotland.

## 1. Household Insurance Legal Protection Policy

Legal expenses insurance – also known as family legal protection – is an extra add on to household insurance that helps cover the costs of your legal fees in certain instances. It is relatively cheap – between £30 and £50 p.a. according to the level of cover.

#### It usually covers:

- > Personal injury claims
- > Employment disputes
- Disagreements about property
- > Problems with the provision of goods and services

Common events that most policies include:

- > Property and neighbour disputes like disagreements about shared driveways
- > Personal injury claims such as a fall on a slippery floor
- > Consumer disputes including shoddy work

Some legal expenses policies might also include:

- > Identity theft cover for when someone opens accounts or buys products using your details
- > Jury service cover for lost earnings while you're serving on a jury
- Inheritance disputes about something left to you in a will
- > Appeals against non-admission to a school
- > Expenses related to an HMRC inquiry into your tax return

You're typically covered for up to £100,000 in legal costs. But some home insurance legal cover only funds up to £25,000 of legal costs.

# 2. Solicitors local to Stirling – Civil Legal Aid provision by law category

A number of private solicitor firms local to Stirling currently provide legal support via civil legal aid. The below table indicates categories of law they cover, based on publicly available information on their websites.

## 3. Referrals for legal cases involving children

There are two main child-focused charities operating in Scotland offering legal support for children, and whilst their support may be similar, the charities differ in their realms of operation.

<u>Clan Childlaw</u> is the only charity in Scotland that provides free, independent legal representation exclusively for children and young people, which is child-centered by design. Lawyers work directly with children and young people whose lives are affected by legal decisions, bringing unique practice-based knowledge to every aspect of their work. This includes a helpline supporting others who help children to use their voices and their rights.

The subjects they list that they help with are - **contact and residence**, **appearing in court**, **adoption**, **retaining housing**, **leaving care**, **obtaining a passport**, **parental responsibilities and permanence**. The subjects tend to be around matters concerned with older children and teens, especially those adopted, in care or leaving care.

The <u>Scottish Child Law Centre</u> helps all ages of children and young people, as well as parents, carers, family members and professionals who work with or for children.

Qualified solicitors can answer any question you may have relating to all areas of child-related Scots law. This includes **education**, **additional support needs**, **health**, **residence**, **contact**, **youth offending**, **accessing records**, **confidentiality**, **children's rights**, **children's hearings and disputes involving the court**.

The following table gives some indication as to the similarities and differences of operation between the two charities based on information available on their websites.

# 4. Cases involving ethnic minorities, migrants, asylum seekers and refugees

There are three main charities in Scotland providing specialist support including legal help and representation for migrants, refugees, asylum seekers and those from minority ethnic backgrounds. Although there is a certain amount of overlap between the three charitable organizations regarding some of the subjects they cover, they tend to focus on different themes, thus signposting and referral to any of them will be dependent on the circumstances of the case in question.

The <u>Ethnic Minorities Law Centre</u> focuses on issues around <u>Discrimination</u>, <u>Immigration & Asylum</u>, <u>Human Rights</u>, <u>and Employment</u>. Based in Glasgow, their contact details are:

The <u>Scottish Refugee & Migrant Centre</u> focuses on issues to do with the <u>protection and safety of women and children and advocating for family reunion for families torn apart by conflict. They operate under the umbrella organization JustRight Scotland and operate a limited Legal Advice Line for professionals and advisers.</u>

The **Scottish Anti-Trafficking and Exploitation Centre (SATEC)** supports migrant victim-survivors of trafficking and/or exploitation. by providing legal advice and representation. As such their work may be often focused on illegal practices and criminal enterprises. The following table gives some indication of the areas of law they each cover and may be helpful in deciding on the circumstances of any given case, which organization may be the most suitable to contact for further support.

## 5. Discrimination and Human Rights– Scottish Just Law Centre

The Equality Act 2010 makes it unlawful in the UK to treat someone less favourably than others because they have a 'protected characteristic' – this is known as discrimination.

The protected characteristics in the Act are:

- > Age
- Disability
- > Gender reassignment (trans identity)
- > Marriage and civil partnership
- > Pregnancy and maternity
- > Race (including traveller ethnicity)
- > Religion or belief
- > Sex
- > Sexual orientation

For people from a minority ethnic background or who are migrants or refugees, the organisations above may be the more appropriate place to refer to for legal support.

For other 'protected characteristics' the <u>Scottish Just Law Centre</u> (SJLC) would likely be more suitable. The SJLC aims to reduce discrimination and disadvantage in Scotland by helping people use equality and human rights law as an effective tool for social change.

People working in an organization that represents individuals as **frontline advisers or support** workers can make a referral to them on behalf of a client or service user who has experienced discrimination or a breach of their human rights in Scotland.

# 6. Disability – Legal Services Agency - Disability and Social Justice Project

Established in 2023, the **Disability and Social Justice Project** provides specialist legal advice, assistance, and representation for disabled people throughout Scotland. The team includes those with lived experience of disability providing them with a unique understanding of the issues that disabled people face in enforcing their rights.

# 7. Housing and Homelessness– Shelter Housing Law Service

The **Shelter Scottish Housing Law Service** helps people access justice by providing specialist and expert advice and representation on housing law.

Solicitors work alongside advisers, providing them with legal support and representation to help their clients with housing issues across Scotland covering the following areas of law:

- > Evictions
- Mortgage repossessions
- > Homelessness
- > Dampness and disrepair
- > Unlawful evictions
- > Abandonment

For citizens of Stirling, funded by the Scottish Legal Aid Board (SLAB), the **Housing Law and Debt Advice Project** aims to help people stave off evictions and repossessions as well as in Tayside, Falkirk, Clackmannan and the Borders.

Representation is provided to clients facing heritable court eviction and mortgage repossession actions and ensures that people who are homeless and haven't been able to obtain appropriate alternative accommodation are able to access local advice, assistance and representation. Legal area covered: debt, eviction, mortgage repossession.

## 8. Domestic abuse victims – Scottish Women's Right Centre

The <u>Scottish Womens' Rights Centre's</u> 08088 010 789 Helpline supports women aged 16 and over who have been affected by violence and abuse in Scotland, providing initial information and support. If a client requires initial legal information, one of their solicitors will call the client back to discuss any questions - all services are free and confidential.

Appointment based legal advice surgeries are available to discuss cases in detail with one of their solicitors and get more specific legal advice.

Two different surgeries are available depending on client circumstances:

- > General advice surgeries for women who have experienced any form of abuse
- > Immigration advice surgeries for women who have experienced gender-based violence and immigration issues

Appointments are generally available every Thursday at 11am, 12pm and 2pm.

## 9. Edinburgh Napier University Law Clinic

**Edinburgh Napier Law Clinic** has been included here because, unlike university law clinics in other Scottish cities that only support local residents, they have indicated that they will take cases from further afield.

Advice from the law clinic is given by law students under the careful supervision of legal professionals and is underwritten by requisite insurance.

The Clinic currently offers free legal advice in **employment**, **private housing and consumer matters**.

Although unable to represent clients in court, the Clinic is an advice agency accredited by the <u>Faculty of Advocates Free Legal Services Unit (FLSU)</u>. Where appropriate, cases may be referred to the FLSU for representation.

Types of case they state that they can handle are outlined in the following table.
